#### **Important Information:**

- Starting January 1, 2024, Admelog and Fiasp will be part of our fast-acting covered insulin products.
- While Humalog<sup>®</sup> is not on our 2024 Formulary, we do have on-formulary alternatives that work the same.
- Admelog is a fast-acting insulin product made by Sanofi that's an alternative to Humalog. It's an insulin lispro like Humalog (made by Eli Lilly).
- Fiasp is also a fast-acting insulin product made by NovoNordisk. It's insulin aspart just like Novolog, which is also made by Novo Nordisk. Fiasp, however, is a newer formulation of NovoLog with niacinamide (vitamin B3) added.
- Your doctor can easily write a prescription for you for any of these covered insulin products.
   In some cases, your pharmacist can switch them automatically!

# **20%** Coinsurance at In-Network Durable Medical Equipment (DME) Providers

When you fill your diabetic testing supplies and CGMs through a DME provider, you'll pay more. The cost is 20% coinsurance at a DME provider instead of a \$0 copay if you get the same supplies and CGMs at an in-network pharmacy.

### Important!

If you use diabetic testing supplies and/or a CGM that is not preferred by our plan, talk with your provider to get a new prescription for preferred items or to request an exception for non-preferred items.
